ARTICLE 2 Referendum Question A: Shall an ordinance entitled “2022 Amendment to the Town’s Zoning Ordinance to Adopt Changes to Article 8, Section 10, York Street Mixed Residential and Commercial Use (MRCU) District to change the lot width for multi-family dwelling/lots from 200 feet to 100 feet” be enacted?

Select Board recommends acceptance of this article by a vote of 6 in favor, 1 opposed, 0 absent.
Planning Board voted a neutral recommendation of this article as a sound planning tool by a vote of 5 in favor, 0 opposed, 0 absent.
