The appropriate fee, payable to the Town of Kennebunk, is due with submission of this Mooring Registration Form on or before April 1, 2023. **Failure to file, and/or submit the annual fee, a completed registration, and the required additional support documents shall result in the loss of your mooring authorization!**

**Mooring Rules and Regulations Adopted from The Kennebunk River Ordinances**

The mooring holder is responsible to provide **black mooring numbers three (3) inches high painted on the white mooring ball** of no less than (20) twenty inches in diameter. This mooring lease is not transferable. Except as approved in writing by the Harbormaster, only the above-named vessel is authorized to lease this property and use this mooring location. The Harbormaster shall have absolute authority over all mooring locations in accordance with the terms of the Harbor and River Ordinance and the laws of the State of Maine. No mooring shall be permitted, and no mooring shall be placed, utilized, or allowed without written authorization from the Harbormaster.

Any mooring location that is NOT UTILIZED by the holder of the mooring authorized and registered herein, or by an assignee approved by the Harbormaster, for a term thirty (30) CONSECUTIVE DAYS during the months of June, July, and August of any year, SHALL BE DECLARED VACANT and shall thereupon be available for reassignment by the Harbormaster.

**The Towns of Kennebunk and Kennebunkport, together with the River Committee and the Harbormaster, assume no responsibility or liability of any kind, for losses associated with moorings, mooring tackle, vessel groundings or tidal conditions in the Kennebunk River.**
