The appropriate fee, payable to the Town of Kennebunk, is due with submission of this Mooring Registration Form on or before April 1, 2026. Failure to submit a completed registration form and fee by this date will indicate a forfeiture of the mooring!

Mooring Rules and Regulations Adopted from The Kennebunk River Ordinances

The mooring holder is responsible for identifying their mooring ball with 3" high black numbers on a White (20 inch) mooring ball. This mooring lease is not transferable. Except as approved in writing by the Harbormaster, only the above-named vessel is authorized to lease this property and use this mooring location. The Harbormaster shall have absolute authority over all mooring locations in accordance with the terms of the Harbor and River Ordinance and the laws of the State of Maine. No additional mooring shall be permitted, and no mooring shall be placed, utilized, or allowed without written authorization from the Harbormaster.

Any mooring location that is NOT UTILIZED by the holder of the mooring authorized and registered herein, or by an assignee approved by the Harbormaster, for a term thirty (30) CONSECUTIVE DAYS during the months of June, July, and August of any year, SHALL BE DECLARED VACANT and shall thereupon be available for reassignment by the Harbormaster. All moorings are to be vacated no later than the end of November 2026.

The Towns of Kennebunk and Kennebunkport, together with the River Committee and the Harbormaster, assume no responsibility or liability of any kind, for losses associated with moorings, mooring tackles, vessel groundings or tidal conditions in the Kennebunk River.
